

The Casebook of Sherlock Holmes Adventure LIV – The Adventure of the Illustrious Client

Since the publication of *A Study in Scarlet* in 1887, many Sherlockian "chronologists" have worked to place the 60 stories into order, based on the date in which the story occurred.

These chronologists have looked at a myriad of items in each of the stories, such as weather conditions mentioned during the story, events occurring at the same time, other stories from the Canon mentioned, and even "trifles" such as statements made in the story.

While there are over 30 or 40 such chronologies that have been developed, the list below provides a good representation of those efforts.
